

#### **ABOUT THE ICA**

The Institute of Contemporary Arts (ICA) is London's leading space for contemporary culture. We commission, produce, and present new work across film, music, performance, and visual arts, engaging today's most progressive artists. Located on The Mall in central London, the ICA is a hub for exploring what it means to live in our world today through a genre-fluid programme that challenges the past, questions the present, and confronts the future. This is our commitment to the extraordinary legacy that began with our founding in 1946.

Our cross-disciplinary approach fosters new combinations and collaborations, with club nights, film festivals, gigs, exhibitions, talks, and digital art at the core of our work. The ICA has a rich history of promoting visionary art, from Kenneth Anger to Jean-Michel Basquiat, Pop Art to queer techno, and remains committed to celebrating risk and championing innovation across the arts.

The ICA is a registered charity and an Arts Council England National Portfolio Organisation, dedicated to fostering a diverse and inclusive environment that encourages dialogue and debate.

#### **ROLE OVERVIEW**

The Chair of the Board of Trustees will lead the ICA's Board in its governance role, ensuring the organisation fulfils its mission and achieves its strategic goals. The Chair will collaborate closely with the Director/CEO and Executive Leadership Team to provide oversight,

guidance, and support as the ICA navigates contemporary challenges and opportunities. This is a pivotal role that requires a deep commitment to contemporary arts, exceptional leadership qualities, and a strategic mindset.

#### **KEY RESPONSIBILITIES**

#### **LEADERSHIP & GOVERNANCE**

- Lead the ICA's Board of Trustees in fulfilling its governance responsibilities, ensuring that the organisation operates within its charitable objectives and complies with legal and regulatory requirements.
- Chair Board meetings, facilitating open and effective discussions, and ensuring decisions are made in the best interest of the ICA.
- Ensure the Board operates as an effective team, with the right balance of skills, experience, and diversity to drive the ICA's mission forward.

#### STRATEGIC OVERSIGHT

 Collaborate with the Director/ CEO to shape and implement the ICA's strategic direction, ensuring alignment with its mission, values, and commitment to diversity and inclusion.



 Oversee the monitoring and evaluation of the ICA's performance against its strategic objectives, driving continuous improvement and innovation.

#### **ADVOCACY & REPRESENTATION**

- Act as an ambassador for the ICA, representing its interests to stakeholders, funders, partners, and the wider arts community.
- Engage with key stakeholders, including government bodies, arts organisations, and the media, to enhance the ICA's profile and influence.

#### SUPPORT & DEVELOPMENT

- Provide mentorship and support to the Director, offering constructive feedback and guidance.
- Lead the Board in succession planning, ensuring the ICA's leadership is sustainable and prepared for future challenges.
- Foster a culture of inclusivity, equity, and transparency within the Board and across the organisation.

#### FINANCIAL STEWARDSHIP

- Work with the Director/CEO, F&A committee, and the Finance Director to oversee the ICA's financial health, ensuring robust financial management and sustainability.
- Ensure that the ICA has the necessary resources (financial, human, and material) to achieve its objectives and continue its legacy of innovation.

#### **FUNDRAISING & DEVELOPMENT**

- Working closely with the Director/ CEO, Development & Partnerships Committee and the team to secure funding from a range of sources including individual donors, corporate sponsors, trusts, and foundations.
- Engage with major donors and potential supporters to build and maintain relationships that will enhance the ICA's financial sustainability.
- Drive the development and implementation of a comprehensive fundraising strategy that aligns with the ICA's strategic goals and mission.
- Advocate for the importance of fundraising within the Board and among ICA stakeholders, ensuring that fundraising efforts are integrated into all aspects of the ICA's activities.

#### PERSON SPECIFICATION

#### **ESSENTIAL**

- We are open to candidates with leadership experience from a range of sectors — whether from within arts, culture, and charity, or from other fields where they have developed relevant skills and share our commitment to the ICA's values and mission.
- Strong understanding of governance and the legal responsibilities of trusteeship.
- Demonstrable commitment to contemporary arts and culture, with a deep appreciation for the ICA's mission and history.
- Strategic thinker with the ability to drive organisational change and growth.

- Experience in fundraising, philanthropy, or securing partnerships within the arts and culture sector.
- Excellent communication, negotiation, and interpersonal skills, with the ability to engage effectively with a wide range of stakeholders.
- Integrity, independence of thought, and sound judgment.

#### **DESIRABLE**

- Knowledge of financial management and budgeting in a non-profit context.
- Prior experience serving on a Board, particularly in a Chair or leadership capacity.

#### TIME COMMITMENT

The Chair is expected to commit to approximately 2 days per month, including attending Board meetings, sub-committee meetings, and representing the ICA at events. There are four quarterly Board meetings and four Finance Sub-Committee meetings each year, with dates arranged in the third quarter of the preceding year. The role may require additional time during periods of significant activity.

#### **TERM**

Trustees serve three-year terms, with a maximum of three terms allowed.

Board meetings are held at the ICA. Though remote attendance is possible, it is not encouraged. Occasionally, an additional strategy day may be planned around the third quarter. Board meetings typically last two hours, with papers circulated five days in advance.

In between Board meetings, the Chair may be contacted by Senior Staff for various tasks such as signing timesensitive documents, reviewing or discussing agenda items in advance, agreeing on meeting dates, contributing to major fundraising plans, following up on trustee action points, or receiving updates on activities or programming.

In the initial months, additional time will be dedicated to induction activities, including meeting with all members of the Board and Senior Management and team of staff.



ICA is incredibly challenging at times because it's responding to what's important in contemporary art, music, film and performance right now. As well as being critical and vital work ICA is nurturing and supporting a future generation through Young ICA Creatives that provides access for young people to not only be consumers of culture but to be producers too. Urgent and pertinent questions fuel the talks bringing leading thinkers into dialogue with each other and the public.
